**Release of Liability and Hold Harmless**

I hereby release, waive, discharge, and covenant not to sue Wild2Ride LLC, Joe Misner, Missy Misner, property owners, each and every agent, employee, partner, rider, or member all for the purposes herein referred to as "Releasees" from all liability to myself, my legal representative, distributes, guardians, assigns, heirs, and next of kin, all for purposes herein referred to as "Releasors", for injury, death or damage resulting from my participation in said instruction and training as a result of the negligence of Releasees, or any employee, servant, agent, or contractor or Releasees. I further release and discharge Releasees from all liability to Releasors for injury, death, or damage resulting from my participation in said instruction and training as a result of the negligence of any other party or parties in attendance. In addition, I hereby release and discharge Releasees from all actions, claims or demands Releasors now have or may hereafter have for injury, death, or damage resulting from my participation in such activities.

I hereby agree to indemnify and save and hold harmless Releasees and each of them from any loss, liability, damage, or cost they or any of them may incur due to my participation in said instruction and training.

I hereby assume full responsibility for risk of bodily injury, death or property damage due to the negligence of Releasees, or any of them, or of any employee, servant, agent, or contractor or Releasees resulting from any participation in said instruction or training.

I expressly acknowledge that activities involving horses involve inherent risks, which mean that there are dangers or conditions which are an integral part of horse activities and include among other things the propensity of a horse to behave in ways that may result in injury,

harm or death to persons on or about them, and the unpredictability of a horse's reaction to such things as sound, sudden movement and unfamiliar objects, persons, or other animals.

### **Riding Helmet and Apparel Warning**

Participant acknowledges that all horse handlers and riders should wear protective headgear which meets or exceeds the quality standards of the SEI certified ASTM standard while riding and being near horses and understands that the wearing of such helmet may reduce the severity of an injury incurred and if Participant chooses not to wear such helmet, Participant assumes all such risk of injury resulting therefrom. All minors must wear protective headgear while riding, without exception.

Participant acknowledges that foot apparel and protective clothing should be worn while riding, and Participant assumes the risk of injury if he or she chooses not to wear riding boots and/or protective clothing

### **Personal Property**

Participant acknowledges that while on the property, direct loss or damage, theft, or injury to Participants tack or equipment is not covered by Releasees insurance. Releasees shall not be responsible for such loss, damage, stolen or injured property

Participant understands that he or she is responsible for carrying his or here own health insurance and personal property insurance

I have carefully read this release and waiver of liability and indemnity agreement and fully understand its contents.
